i. Early Bird season pass rates available until Friday, Dec. 5, 2009.

iii. Children under 5 have free trail use but pay for rentals.

iv. Corporate Pass includes two transferable season passes at the Callaghan Valley and seasonal rentals (skis and snowshoes).

v. Family is defined as two adults and their dependant children (under 18 yrs) living in the same residence.

vi. Seasonal rentals are good for skate or classic gear and snowshoes. Equipment stays on-site. Short term exceptions are possible with notification. Pemberton, Whistler & Squamish ski club members will receive 25% off

BONUS OFFER:

Season Pass buyers receive a two-for-one rental voucher and one free day pass. Season Pass holders are also eligible for discounts on lodging at Callaghan Country's backcountry lodge.

As a season pass holder at Whistler Olympic Park, Callaghan Country and/or Lost Lake Park I understand and hereby agree to the terms and conditions of sale as follows:

1. I will OBEY all warning, closure signs and other notices posted within the ski area and facilities and OBEY the Alpine/Cross-Country Skier's Responsibility Code.

2. The pass remains the property of Whistler Olympic Park. My season pass may be subject to CANCELLATION or REMOVAL by Whistler Olympic Park, Callaghan Country and/or Lost Lake Park without refund at its sole discretion. The privileges and services the season pass grants may be revoked in the event of misconduct, fraudulent use of the pass, failure to observe posted notices or warnings, or failure to obey the Alpine/Cross-Country Skier's Responsibility Code.

3. The season pass holder shall be responsible for any misuse of the pass, whether or not the misuse occurred with the pass holders knowledge or consent. Season pass holder is RESPONSIBLE FOR PROPER USE OF THEIR SEASON PASS AT ALL TIMES.

4. In the event that I forget my season pass, a day ticket will be issued to ski that day from the guest relations office in the day lodge. (This courtesy is offered ONCE per season. Tickets will have to be purchased for subsequent occurrences).

5. If I lose or break my season pass, I will notify Whistler Olympic Park, Callaghan Country and/or Lost Lake Park immediately, and if the pass is not found, I will be required to pay a \$30 REPROCESSING FEE.

6. A \$30 fee will be charged for RETURNED CHEQUES.

7. I will present my season pass for inspection UPON REQUEST.

8. Once purchased, my season pass is NON-TRANSFERABLE AND NON-REFUNDABLE, under any circumstances unless otherwise specified.

9. Season passes are valid for the 2009/2010 winter season, expiring at season's end 2010.

10. I understand that Whistler Olympic Park is a competition venue for the Vancouver 2010 Olympic and Paralympic Winter Games; as such there will be trail closures through the season to run events. I accept this as normal operating procedure and will adhere to trail closure notification.

11. I have read, understand, and I have signed or will sign the RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS, AND INDEMNITY AGREEMENT. I also understand that my season pass will not be issued to me if the agreement is not completed in full, dated, signed, and witnessed. (Persons 18 and under will require the signature of a parent or legal guardian).
